A Corporate Membership may be held in the name of a partnership, company, or other form of multiple ownership, (collectively the entity).

Each Corporate Member may designate up to 6 (six) corporate designees that will have full Membership privileges in the Club, provided such individuals are either: directors, officers, partners or employees of the entity.

Each designated user of the Corporate Membership will have the ability to select either an Individual or Family Resident or Non-resident Golf or Leisure Membership. And will be entitled to use the Club Facilities on the same basis as a regular member of the Club. Each designated user must complete an application for membership and will be responsible for the dues and fees associated with the class of membership that they elect.

A Corporate Member may change one or more of the designated users one time per membership year.

The Corporate Member would be responsible for any unpaid dues, fees and other charges incurred by its designated users and not paid on a timely basis.

The current Initiation Fee for a Corporate Membership is \$30,000. This fee can be paid in five annual installments of \$6,000 with no interest.

Annual Corporate Golf Membership

The Annual Corporate Golf Membership allows the company to designate three Individuals to use the membership.

A Corporate Membership may be held in the name of a partnership, company, or other form of multiple ownership (collectively the entity).

Each Corporate Member may designate up 3 (Three) corporate designees that will have full Membership privileges in the Club, provided such individuals are either directors, officers, partners or employees of the entity.

Each designated user of the Corporate Membership will have the ability to select either an Individual or Family Golf Membership. And will be entitled to use the Club Facilities on the same basis as a regular member of the Club. Each designated user must complete an application for membership and will be responsible for their own fees and charges associated with the class of membership that they elect.

A Corporate Member may change one or more of the designated users one time per membership year.

The Corporation will pay an Annual fee currently \$5,500 and will be responsible for the monthly dues, currently \$475.00.

The Corporate Member would be responsible for any unpaid dues, fees and other charges incurred by its designated users and not paid on a timely basis..
